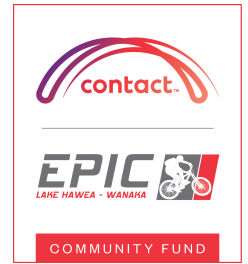


Contact Epic Community Fund objective

By submitting an application for a grant from the Contact Epic Community Fund, you agree to the following terms and conditions if your application is accepted:

1. The "Organisers" of the Contact Epic Community Fund are Contact Energy Limited, LMS Events Limited and the Hawea Community Association.
 2. You will spend the grant only for the purpose(s) approved by the Organisers and will return any portion of the grant that is not spent for such purpose(s).
 3. You consent to the use of your name, photo, amount granted to you and story by each of the Organisers for publicity purposes.
 4. You confirm that the details submitted by you in support of your application are true and correct to the best of your knowledge and belief and that you reside or are based in the Hawea District. Any incorrect information provided by you may invalidate any grant made to you.
 5. The successful applicants will be chosen by the Organisers at their sole discretion. If a successful applicant cannot be contacted within four weeks, the grant money may be allocated to another applicant.
 6. Personal information supplied by you will be used by the Organisers for the purposes of administering and promoting the Contact Epic Community Fund. You have the right to access and correct personal information held by us.
 7. You confirm that you are authorised to make this application on behalf of the organisation you represent (if applicable).
 8. Employees of Contact or LMS Events or members of HCA Executive Committee are excluded from applying.
